

# **CIAO DARCY AGREEMENT & POLICIES**

### **Pre and Post Tour**

Ciao Darcy highly recommends that you arrive at least one day prior to your tour date in order to acclimate to any time differences. Ciao Darcy can help with any recommendations for hotels before or after your tour.

# **Cancellation Policy**

If you need to cancel your tour before departure, the following fees must apply at the time we receive your written cancellation notice.

From 60 to 30 days before departure: 50% of tour price Less than 30 days before departure: 100% of tour price

# **Required Trip Insurance**

Please note that trip insurance is required to join us on a Ciao Darcy trip. Trip cancellation insurance will protect all deposits and payments for land and air costs if you are required to cancel your tour. We recommend<u>www.travelguard.com</u>. FYI: most major credit cards (such as American Express, CHASE Sapphire, and Capital One) offer complimentary insurance when you purchase using their card.

#### **Minimum Travelers**

Minimum Travelers: We only run trips with 4 or more guests. If a trip has fewer attendees at 30 days before the trip dates, we will cancel the trip. However, if this were to happen, we can give you the option of a private tour with a surcharge applied.

# **Medical Insurance**

Ciao Darcy recommends everyone carry medical and personal insurance to cover hospital and other medical expenses. Medical insurance can be purchased through <u>www.travelguard.com</u>, it is listed under: Worldwide Health or go to <u>www.travelersmed.com</u> which carries short-term medical insurance.

control. Ciao Darcy, LLC is not responsible for any additional expenses (purchase of non-refundable airline tickets, visa fees, equipment or additional lodging). You will be at that time refunded the full tour price.
